



Sasquatch Country Adventures Waiver Agreement

Notice: This is a legally binding contract. In consideration of my being permitted by Sasquatch Country Adventures to participate in their guide services provided, I agree to the following waiver and release and I make the following representations:

I hereby acknowledge the risk of potential dangers in participating in outdoor activities. I realize that those risks include, but are not limited to: natural disaster, failure of equipment, occasional meetings with wildlife, and freakish accidents which cannot be foreseen. I acknowledge that the above list is not inclusive of all possible risks associated with the service provided by Sasquatch Country Adventures and I agree that said list in no way limits the extent or reach of this release.

I voluntarily assume all such risks with full knowledge and appreciation of the danger and risk involved.

I voluntarily agree to assume all risk of personal injury, including paralysis and death, that may occur while I am participating in the services provided by Sasquatch Country Adventures. I hereby knowingly and intentionally waive and release, and agree to indemnify, hold harmless and defend Sasquatch Country Adventures, its, staff, affiliated organizations and agents from all liability for any such damage, injury, paralysis or death which may result.

I am in good health and have no physical limitations which would affect my participation in the services rendered by Sasquatch Country Adventures. I certify that I have read the rules, and I agree to abide by these rules and any future rules, and if the staff guide makes a specific request of or instruction to me, I agree to comply.

I am at least 18 years of age and otherwise legally competent to sign this agreement. This release shall be effective and binding upon me and my assigns, heirs, representatives, executors and administrators. If under the age of 18, this release must be signed by the parent/guardian of the minor, and I agree to indemnify and hold harmless Sasquatch Country Adventures and the other released parties in the event a minor member of my family sues them or any one of them.

I understand that this release is a contract. No oral representations, statements or inducements apart from the above written agreement have been made. I expressly state that I have read, understand and am familiar with all its provisions and that I sign it of my own free will. I further expressly agree that this release, waiver and indemnification agreement is intended to be as broad and inclusive as is permissible by the laws of the Province of British Columbia and that if any portion of this agreement is held to be invalid, it is agreed that the balance shall, notwithstanding, continue in full force and effect.
